Sub : Recognition Certificate for the School under sub rule (4) of rule 11 of Right of Children to Free and Compulsory Education Rules , 2011 for the purpose of section 18 of the Right of Children to Free and Compulsory Education Act, 2009 .

Dear Sir/Madam ,

With reference to your application dated 23/06/2023 and subsequent correspondence with the school/inspection in this regard , I District Education Officer (Primary)Zilha Parishad,Wardha District- Wardha convey the grant for provisional recognition to the Saksham School , Pawnar Tal.Dist. Wardha (name of the school with address) for class - 1st Std to class 8th Std for a period three years w.e.f 01/04/2023 to 31/03/2026

The above sanction is subject fulfillment of following conditions :-

- 20) The grant for recognition is not extendable and does not in any way imply any obligation to recognized or affiliate beyond class VIII .
- 21) The School shall abide by the provisions of Right of Children to Free and Compulsory Education Act , 2009 (Annexure I) and the Maharashtra Right of Children to Free and Compulsory Education Rules , 2011 (Annexure II).
- 22) The School shall admit in class I , to the extent of 25% of the strength of that class children belonging to weaker section and disadvantaged group in the neighborhood and provide to them free and compulsory elementary education till its completion .Provided , further that in case of pre - primary classes also ,this norm shall be followed .
- 23) For the children referred to in paragraph 3 , the school shall be reimbursed as per Section 12 (2) of the Act . To receive such reimbursements school shall provide a separate bank account .
- 24) The Society/School shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure .
- 25) The school shall not deny admission - To any child for lack of age proof - On the ground of religion caste or race , place of birth or any of them .
- 26) The School shall ensure :
 - (i) No child admitted shall be held back in any class or expelled from school till the completion of elementary education in the school .
 - (ii) No child shall be subjected to physical punishment or mental harassment ;
 - (iii) No child is required to pass any board examination till the completion of elementary education.
 - (iv) Every child completing elementary education shall be awarded a certificate as laid down under Rule 23.
 - (v) Students with disabilities/special needs are included as per provision of the Act .
 - (vi) The teachers are recruited with minimum qualification as laid under section 23 (1) of the Act . Provided further that the current teachers who , at the commencement of the Act do not possess minimum qualifications shall acquire such minimum qualifications within a period 5 years .
 - (vii) The teacher performs his or her duties specified under section 24 (1) of the Act and
 - (viii) The teachers shall not engage himself or herself for private teaching activities .
